# Dave Reynolds, Moscow Ambulance EMS Division Chief: Advisory Committee Update

- Dave reported that the Advisory Committee met in April.

### Decontamination Survey

Only eight organizations have completed the survey so far. Circe will send out the survey again. Coalition members were strongly encouraged to complete the survey if they have not already done so.

# Interoperable Communications (1 CEU) - Don Gardner, Clearwater County Emergency Manager

- Don explained interoperable communications within our region.
- Wider bandwidth is better than narrow because wider banding carries more energy. This enables the message to be carried around obstacles.
- P25 radios only handle narrow banding.
- An analog signal cannot be received by a digital radio. In order to communicate effectively everyone should be using either analog or digital (one or the other).
- Plain English should be used in a mutual aid event according to the National Incident Management System standards.
- ➤ On June 30<sup>th</sup> the public can send limited text 911 messages.
- Recommendations for improvement are to adopt Tac channels and develop a communications plan for large events.

### WebEOC and Hospital Mass Fatality Plans - Kayla Moehrle, Public Health Planner

- > The Regional Mass Fatality Plan just went through its second revision.
- A hospital mass fatality plan was developed with Circe's assistance. This document may be added as an attachment to the mortuary operations section of a hospital's plans. The hospital mass fatality plan helps hospitals know what resources are available to them in regards to remains storage, remains removal, and family assistance centers. Kayla will send hospitals an electronic copy of the hospital mass fatality plan.

# Memorandums of Understanding (MOUs) – Mel Johnson, Nez Perce County Emergency Manager

- Mel explained that MOU's and MAA are very similar; however, an MAA may be a hand shake whereas an MOU may be an actual document.
- > MOUs hold up in court as legal agreements, but not contracts.
- MOUs are developed due to resource limitations, for reimbursement purposes, to educate policy makes, to save time, and to implement regional plans.
- MOUs build capability through resource sharing, defining roles and responsibilities, educating policy-makers, cementing relationships, and identifying gaps.
- ➤ The standard components of an MOU include: introduction, purpose/scope, definitions, policy, procedures, maintenance (updates, duration), and signatures (by appropriate legal authority).

### Joint Patient Assessment and Tracking System (JPATS) & FY2013 ASPR Grant Timeline – Rachelle Burrup, Public Health ASPR Coordinator

- ➤ JPATS is a national system the state is looking at implementing. It is compatible with Hospital Language 7 which is the standard language for interoperable hospital data systems.
- ➤ The next grant cycle (ASPR Allotment XII) begins July 1<sup>st</sup>. Applications will be sent out then. If an organization is interested in applying for ASPR funds they need to contact Rachelle (<a href="mailto:rburrup@phd2.idaho.gov">rburrup@phd2.idaho.gov</a>) by June 28<sup>th</sup>. Funds are
